



Notice of Application Opportunity for the HVAC Mechanic Apprenticeship Program

The Heating, Ventilation, Air Conditioning (HVAC) Mechanic Apprenticeship Program is a paid apprenticeship program, with sponsored education provided to the selected apprentices at no charge. Applicants must submit a completed application, pass the aptitude test, and attend an interview to be placed on a list to be selected by one of the major motion picture studios in the Los Angeles area. The list will be valid for two years. Step 1: Submit a completed application in person

When: Applications will be accepted **in person** starting Monday, April 6 – Friday, April 10, 2026, from 9:00 a.m. - 5:00 p.m.

Where: Contract Services Administration Trust Fund: 2710 Winona Avenue, Burbank, CA 91504

For an application to be considered complete, **the following are required by the time of application:**

1. Complete an HVAC application **in person**; this application will be provided to you onsite.
2. Present a valid government-issued photo identification **in person** to show you are at least 18 years of age.
3. Present proof of High School completion in one of the following forms:
 - An official and **sealed** copy of your High School transcripts signed by the Registrar's Office or
 - GED certificate showing High School completion.
4. Present proof of Algebra completion in one of the following forms:
 - An official and **sealed** copy of your High School transcript showing successful completion of **two semesters of high school algebra with a grade of C or better**, or
 - An official and **sealed** copy of college or adult school transcript showing **one semester of college algebra with a grade C or better**, or
 - A training certificate for the Online Tech Math course provided through the Electrical Training Alliance. The course must be completed **prior** to the time of application. The course can be found here: <https://www.electricaltrainingalliance.org/Learning/OnlineTechMath>

Documentations above must be received by the time of applying. Items #3 and #4 can be submitted in person, or by mail: Contract Services Administration Trust Fund: 2710 Winona Avenue, Burbank, CA 91504, or by email: apprentice@csatf.org Do not send documentations to IBEW Local 40.

Once the first 225 fully completed applications have been received, we will not accept additional applications.

Step 2: If you meet the requirements listed in Step 1, you will be scheduled to take an aptitude test.

Step 3: If you meet the passing test score, you will be scheduled for an interview.

Step 4: After completing the interview, your name will be placed on the dispatch list for a period of approximately two (2) years until the new dispatch list becomes available. If you were not selected as an apprentice within this two-year period, you must re-apply to the Program.

Applicants must meet the physical prerequisites including being able to safely perform the work of the trade/occupation, and drug testing is mandatory prior to employment.
